STUDENT INTERDISTRICT ATTENDANCE CONTRACT

Pursuant to the provisions of Board Policy 5118 and Administrative Regulation 5118, my child
[If more than one child, complete a separate contract for each child]

_____, has been granted the privilege to attend Sonora School District by virtue of an interdistrict attendance permit. I understand and agree that the Superintendent or his or her designee may revoke during the school year my son or daughter's attendance at Sonora School District pursuant to the interdistrict attendance permit upon the occurrence of one of the events listed below. I also understand that the Superintendent or his or her designee can revoke my son or daughter's attendance at Sonora School District during the middle of a school year even if I have other children attending pursuant to interdistrict attendance permits.

1. The student engages in any misconduct, including, but not limited to, the violation of law, school rule or school directives, whether or not such misconduct constitutes a violation of Education Code section 48900, et seq.;
2. The student fails to maintain a satisfactory record of attendance, including timely attendance;
3. The student fails to maintain a grades of "C" or "S" or better in all his or her classes. "D," "F," "U," "Needs Improvement," "Incomplete," or "No Mark" are all considered unsatisfactory grades;
4. The attendance of the student violates class size limits as determined by the Administrative Regulations;
5. The attendance of the student displaces a resident pupil in light of class size limitations or other considerations;
6. The attendance of the student requires the addition of a special program, service, or class which would constitute a fundamental change in the delivery of student services;
7. The attendance of the student violates the cap, if any, on the number of transfers set forth in Education Code section 48204(f)(6);
8. The attendance of the student negatively impacts the District's voluntary desegregation plan, if any.

I understand and agree that it is my responsibility to provide transportation for my child to and from school. I understand and agree that my child is to be picked up from school following the dismissal from class no later than _____ p.m. unless under the direct supervision of a teacher for a specified reason (athletics, band, etc.)

I understand and agree that the District may place my son or daughter in a particular class within the District at its discretion, and that the District may make this placement after consideration of the availability of space in a class or at a school. I further understand and agree that the District may change this initial placement as concerns regarding availability of space change. I specifically understand and agree that the District faces certain limits upon class size, and that my son or daughter will not be permitted to displace a student whose parent, guardian, or caretaker reside within the District.

I understand and agree that I must annually renew my interdistrict attendance permit.

I understand and agree that the failure of me, my son or daughter to abide and follow these conditions on a daily basis may result in the unilateral recession of the interdistrict attendance permit during the middle of the school year for which the permit was approved and necessitate my child returning to the district of his or her residence.

I understand that I do not have the right to appeal to the Governing Board the Superintendent's decision to revoke my son or daughter's interdistrict attendance permit.
